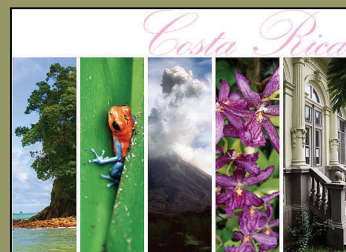


What's in a Sabbatical?
